
The volunteer health care provider program allows volunteer health care professionals to provide their services without charge to individuals who are uninsured, low-income and not eligible for General Relief, Medicaid or Medicare. Volunteers include state licensed: physicians, dentists, optometrists, registered and practical nurses, nurse midwives and physician assistants. To participate in the volunteer health care provider program the health care provider's joint application with the nonprofit agency must be approved by the Department of Administration (DOA)

This bill defines "abortion-related activity" and prohibits DOA from approving a joint application from a volunteer health care provider who, or a nonprofit agency that, engages in an abortion -related activity.

For providers and services covered by this program, the volunteers become an agent of the State (DHFS) and are afforded the broad liability protection of s.895.46, Wisconsin Statutes. To this date, there have been no claims of malpractice against the State based on health care provided through the volunteer health care provider program. It is assumed that the exclusion of these providers will not incur a liability claim against the State. The bill has no fiscal impact.


