<b>Assumptions Used in Arriving at Fiscal Estimate</b>		
<ol style="list-style-type: none"> <li>This fiscal estimate addresses only the portion of AB 730 that would authorize the payment of State aid from the Transportation Fund to a local professional football stadium district created under other provisions of the bill.</li> <li>As drafted, the bill would authorize the Department of Transportation to make aid payments of unspecified amount to a professional football stadium district, "for the development, construction, reconstruction or improvement of bridges, highways, parking lots, garages, transportation facilities or other functionally related or auxiliary features or structures associated with a football stadium...."</li> <li>The bill would create a new continuing appropriation from the Transportation Fund for the purpose of making the aid payments to the football stadium district. Transportation aid payments to a football stadium district could only be made from this appropriation; the total amount of aid would be controlled solely by the amount appropriated for this purpose. The timing of aid payments is not specified.</li> <li>In its current form, the bill reflects no funding amount for the proposed new football stadium district aid appropriation from the Transportation Fund. Since the bill neither makes an appropriation nor directs any expenditure for the football district aid program, the fiscal effect, if any, cannot be determined from the bill; it would depend on future action by the full Legislature or the Joint Committee on Finance.</li> </ol>		
<b>Long-Range Fiscal Implications</b> Indeterminate. The ultimate fiscal effect of the provision authorizing DOT to make aid payments to the football stadium district is dependent on the amounts that may be ultimately appropriated. In the event funding is provided, the bill does not specify the timing of when payments would be made and no program sunset date is indicated.


