

Assumptions Used in Arriving at Fiscal Estimate <p>This bill eliminates the fifth standard for emergency detention. It also eliminates the 12/1/02 sunset date for the fifth standard for involuntary civil commitment of persons with mental illness. Under the bill, no petition for the involuntary commitment of a person under the fifth standard may be filed unless the attorney general has reviewed and approved it.</p> <p>It is expected that the number of such hearings in the circuit courts will decrease under these provisions. No data is available on the number of emergency detention petitions that are filed presently and would not be allowed under this bill. It is also impossible to predict how many petitions for involuntary commitment under the fifth standard would not be approved by the attorney general. The decrease in court workload would reduce the costs for operating the circuit courts. Judge, court reporter, and court staff time are costs that are borne by both the state and the county. The exact savings to the state and the county cannot be determined with the data available</p>
