

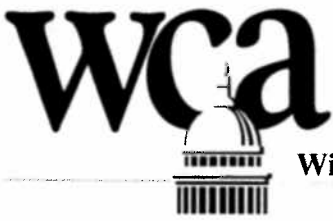

SUBJECT: Support for Assembly Joint Resolution 39

The Wisconsin Counties Association (WCA) supports Assembly Joint Resolution 39, which authorizes the legislature to provide for six-member juries in misdemeanor cases.

Six person juries in misdemeanor cases will provide counties with significant cost savings. The ability to choose six jurors will reduce the time needed to pick a jury in misdemeanor cases that go to trial, as well as reduce the number of potential jurors a county needs to summon. Counties will realize additional cost savings as counties will pay out less revenue in juror daily fees and mileage.

Mandating juries of six in misdemeanor cases, as opposed to language currently found under 756.096 (3)(b), which allows a party to request a greater number of jurors, is extremely beneficial to counties as it avoids frivolous requests for expanded juries which counties currently experience under 756.096 (3)(b), Wisconsin Statutes.

WCA respectfully requests your support for Assembly Joint Resolution 39.
