Dear Chairman Ainsworth:

Because Assembly Bill 202 is a bill that has a potential impact on my Town, I wish to encourage your support of this bill. For too long in this State, urban towns have suffered under the outdated laws which have consistently treated towns unequally when compared to villages and cities.

AB 202 will begin to allow urban towns with many costly infrastructures to begin to compete with their neighbors. If "TIF" districts are good for revitalizing villages and cities, why would it not be good for towns?

White it is true, AB 202 would create another "level" of government, in real life that level already exists. My town of over 18,000 citizens has its own police force, sanitary districts, fire department with some full-time fireman, street department community development department, etc. We exist as a true functioning urban area.
