## **CLEARINGHOUSE RULE 99–024**

#### **Comments**

[NOTE: All citations to "Manual" in the comments below are to the Administrative Rules Procedures Manual, prepared by the Revisor of Statutes Bureau and the Legislative Council Staff, dated September 1998.]

## 2. Form, Style and Placement in Administrative Code

- a. In Sections 6 and 7 of the rule, the term "(title)" can be deleted since both Sections are creating new provisions.
- b. In Section 9 of the rule, the title should be written in solid capital letters. [See s. 1.05 (2) (c), Manual.]
- c. In s. NR 15.022, the title should be shown in bold typeface. [See s. 1.05 (2) (b), Manual.]
- d. In Section 11 of the rule, the title in s. NR 15.024 should be written in bold typeface. [See s. 1.05 (2) (b), Manual.] Also, in the amendment to the title to sub. (1), the addition of the subsection title should follow the striking of the amended title as follows: "(1) PEAT LAKE KENOSHA COUNTY."
- e. The treatment clause of Section 12 of the rule contains the parenthetical phrase "(as amended by clearinghouse order no. \_\_\_\_\_)". It appears that this phrase is unnecessary and should be deleted.

## 4. Adequacy of References to Related Statutes, Rules and Forms

In Section 3 of the rule, the treatment clause indicates s. NR 10.01 (6) (a) is being amended. It appears, however, that the correct reference should be to s. NR 10.01 (3) (e) 6. a. In addition, a reference to "NR 10.01 (3) (e) 6." should be inserted before the "a." in the substantive portion of Section 3.

## 5. Clarity, Grammar, Punctuation and Use of Plain Language

Section NR 10.145 (5) allows the department to require successful applicants to file a harvest report in a manner "prescribed by the department." Where is the manner prescribed? Can an appropriate cross-reference be provided, or a note added, that would help clarify this issue?







#### REPORT TO LEGISLATURE

NR 10, Wis. Adm. Code
Hunting and trapping

Board Order No. WM-1-99 Clearinghouse Rule No. 99-024

#### Statement of Need

The proposed rule changes will improve hunting and trapping opportunities, create protected areas for nesting islands and reclassify the legal status of wolves. The proposed rule:

- 1. Changes the fall turkey season opening date to the Saturday nearest October 10 and changes the season length from 28 to 30 consecutive days. Lengthening the season will not negatively impact the turkey population nor will it dramatically increase harvest rates.
- 2. Establishes a 9-day either sex deer season for Mississippi River deer management units. The existing season structure allows hunters to take a deer of either sex for the first 2 days of the season with their regular license. For the remaining 7 days the regular license is valid only for bucks. The proposed rule would establish a 9-day either sex season bag limit for the river block units. It simplifies season structure and reduces enforcement problems. Bonus antierless permits would continue to be available.
- 3. Changes the opening of the bear hunting season to the first Wednesday in September after Labor Day and extends the season by 7 days. Specifically, the season changes from a 21-day season to a 28-day season in Zones A and B where the use of dogs for bear hunting is permitted, and from 28 days to 35 days in those portions of bear management Zones A, B and C where the use of dogs for bear hunting is prohibited.
- 4. Establishes an overwinter statewide population goal of 13,000 otters. To determine annual harvest quotas, the department must establish a population goal. The department proposes to initially establish a statewide population goal. As we gather sufficient data, the statewide goal will be broken down into goals for each otter management zone.
- 5. Establishes season closure authorization for the bobcat, otter and fisher season. This will allow the department to close the season upon finding that the harvest for the season will exceed the level authorized by the department.
- 6. Expands the early Canada goose hunting zones. Wisconsin's giant Canada geese population continues to increase at about 10% annually. Opening the early season Canada goose season to encompass the rest of the state will provide additional hunting opportunity and properly manage the expanding population.
- 7. Allows deer hunting in wildlife refuges during the muzzleloader deer season. Currently, only gun deer hunting is allowed in the majority of southeastern Wisconsin's wildlife refuges. This proposal would allow muzzleloader deer hunting during the 7-day muzzleloader deer season.

- 8. Establishes a no entry wildlife status for the Big Muskego Lake nesting islands in Waukesha county. The endangered Forster's tern, among other wetland species, nest on the cattail islands. This rule will prevent human disturbance to 3 nesting islands during the nesting season.
  - 9. Changes the legal status of wolves from endangered to threatened.

#### Modifications as a Result of Public Hearings

As a result of comments, the length of the bear hunting season was extended. The proposal to allow the use of telescopic scopes on muzzleloaders during the muzzleloader season was deleted on a vote of 1,126 yes to 3,885 no. The proposal to create an in-season harvest monitoring system for bobcat, otter and fisher was deleted on a vote of 1,818 yes to 2,112 no.

#### Appearances at the Public Hearings and Their Position

Public hearings were held in all 72 counties on April 12, 1999. Individual appearance slips were not filed for these hearings. Total attendance at all hearings was 6,756. Individuals did not indicate a preference on all questions.




