Dear State Agency Head:

We are writing in regards to the emergency rule making process.

As you know, state agencies are permitted to promulgate an emergency rule when such a rule is necessary for the "preservation of the public peace, health, safety or welfare" *and* if there is no time to go through the permanent rule making process. § 227.24(1)(a), *Stats.*

On many occasions in the past year, the Joint Committee for Review of Administrative Rules did not make any determination about whether the statutory requirements for emergency rule making were satisfied. However, several recent rules have given us reason to question our own role in permitting the promulgation of emergency rules that do not satisfy the statutory requirements for emergency rule making.

The purpose of this letter is to let you know that in the coming year the Joint Committee will be paying closer attention to this issue. One consequence of our stricter review may be the suspension of all or part of rules that do not satisfy the statutory criteria.

In addition, if you do promulgate an emergency rule, please be sure to include a clear statement of how the statutory criteria are satisfied. This is required by section 227.24(3) of the statutes. Please avoid rote recitation of the need to preserve the public health, safety and welfare. Instead, provide a clear, common language statement of both how Wisconsin residents will be protected by the rule and why that protection cannot wait for completion of the permanent rule process.

We appreciate your cooperation in the matter and look forward to working with you to ensure that the public's health, safety and welfare truly are protected by the state's administrative rules.

Dear Senator Robson and Representative Grothman:

As members of the state Assembly, we request that the Joint Committee for Review of Administrative Rules hold a public hearing on the failure of the Department of Natural Resources to draft rules to enforce the Mining Moratorium Law (1997 Wisconsin Act 171). We further request, pursuant to Section 227.26(2)(b) of the state statutes, that the committee require the Department of Natural Resources to promulgate as an emergency rule all decisions made by the agency that provide direction to agency staff regarding the interpretation and enforcement of this law.

The Mining Moratorium Law has been in effect for more than a year and a half. In 1998, a bi-partisan group of 32 Legislators joined 42 environmental and conservation groups to request that the DNR create rules for enforcement of the law. The DNR, however, has refused to do so.

At its December meeting, the DNR Board acted on a citizens' petition submitted to the department by the Assembly and Senate authors of the bill along with other state leaders to request the DNR establish rules to enforce the mining moratorium law. The Board denied the petition. However, it has become clear that the DNR is making crucial decisions on the interpretation and enforcement of the mining moratorium law without drafting administrative rules.

The need to promulgate administrative rules is not discretionary under state statutes. Chapter 227.10(1) of the statutes reads, "Each agency shall promulgate as a rule each statement of general policy and each interpretation of a statute which it specifically adopts to govern its enforcement or administration of that statute." When an agency interprets state statute and decides how it will implement state law, rules must be promulgated. This process gives the public a chance to comment and gives the legislature a chance to review an agency's interpretations to ensure these interpretations are consistent with legislative intent.

The DNR has already made numerous decisions regarding interpretation of the law without promulgating administrative rules. Secretary Meyer's November 30, 1999 memo to the Natural Resources Board indicates the Department has made interpretative decisions regarding the data collection standards, criteria for mines eligible to meet statutory requirements and key definitions of environmental pollution. These interpretations weaken the law and make it easier for a mining company to obtain a permit to develop a sulfide mine in Wisconsin. The DNR interpretations appear to be contrary to legislative intent. In any event, they are interpretations of the statute, which require rule making. The lack of administrative rules eliminates the opportunity for the public to review and comment on the agency's interpretations and eliminates the legislative oversight provided for in Chapter 227.

I am writing to request that this item be placed on the agenda of the next meeting of the JCRAR.


The JCRAR has authority pursuant to section 227.26(2)(b), *stats.*, to order an agency to put policies and interpretations of statute in rule form.

The DNR has begun to implement the requirements of the mining moratorium law. The department has made interpretive decisions in such areas as data collection standards, what criteria other mines must meet to be eligible for consideration as comparison mines, and definitions of environmental pollution.

However, none of these decisions are codified in administrative rules. The JCRAR should take public testimony on the question of whether these decisions should in fact be put in rule form.

Please let me know at your earliest convenience if you are willing to place this item on the next JCRAR agenda. Thank you for this consideration.
