
The Kenosha County Division of Health supports Senate Bill 232 relating lead hazard reduction and control. The bill has several key features that address prevention of childhood lead poisoning and provides resources for lead prevention programs and abatement.

They are as follows:

- Requires owners of pre-1950 dwellings to conduct lead screens or risk assessments and to meet specified maintenance and treatment standards. Current lead programs address a dwelling only after a lead poisoned child is identified. Senate Bill 232 will require older homes to be assessed for lead hazards and properly maintained so that children are not poisoned in the first place.
- Creates an incentive for property owners to comply with the maintenance and treatment standards by providing immunity from civil liability.
- Provides funding for lead abatement. There currently is no funding that I am aware of for property owners to utilize for lead hazard control. Senate Bill 232 directs WHEDA to make available at least \$5,000,000 per year for this purpose.
- Provides funding for lead prevention programs. SB 232 provides for continuing GPR funding for lead poisoning prevention programs. Lead prevention grant dollars have been steadily decreasing over the past 5 years. Additional funding will give local health departments the ability to maintain and improve their lead prevention activities.
- Requires facilities serving children under 6, such as day care centers, to have children tested for lead. Screening young children is an integral component of an effective lead prevention program. SB 232 will increase the number of children tested.

In summary, Senate Bill 232 is good public health policy. It promotes prevention. It also provides much needed funding for lead prevention programs and abatement. The Kenosha County Division of Health supports Senate Bill 232.


RE: SENATE BILL 232

Dear Senator Wirch:

The civil liability immunity provided to landlords under certain conditions by Senate Bill 232 will be an incentive for property owners to take a proactive stance to abate potential lead hazards before a child becomes poisoned. However, nowhere in the bill is immunity offered to local municipalities that aspire to address lead hazards. The potential exists within Senate Bill 232 for the imposition of massive liabilities for local government wanting to protect its citizens. For example, the requirements imposed on the State by changing "may" to "shall" in several places in the bill would undoubtedly be passed on to municipalities, creating mandatory duties that municipalities have no ability to fund or accomplish. Without immunity, municipalities may be seen as a "deep-pocket" in civil cases – especially when certain property owners are taken out of the loop.

The City of Racine Health Department fears that the lack of immunity may cause some municipalities to abandon the business of addressing lead hazards altogether and to simply allow the state Department of Health and Family Services to respond to all cases of lead poisoned children. Such a drastic move would not be in the best interest of the people of Wisconsin, and I strongly urge Senate Bill 232 to be amended to grant civil liability immunity to municipalities.


I've been a landlord since 1988 and I'm concerned about the lead problem in housing. I'm going over my apartments when someone moves to try to get rid of any lead. I take the windows out and remove the paint down to the bare wood, reglaze the windows, repaint the windows, install aluminum jamb liners, install a piece of steel in the window well and reinstall the window. I've never considered windows to be a problem until a couple of years ago. When someone moved I just repainted the inside of the window. I never gave much thought to the outside of the window. The outside of the windows are protected by the aluminum storms. I have approximately 182 windows in the apartments I own which may have lead paint on them. I've repaired 127 of the windows so far.

I would like to be considered to be one of the better landlords. I don't want to be lumped into the landlords like in the "Antwaun A. vs. Heritage Mutual" lawsuit. When I purchased some apartments in 1988 the previous landlord didn't rent to tenants with children. I continued the practice until the law was changed to make it unlawful to discriminate against tenants with children. The government allowed the paint companies to manufacture lead paint. The government allowed the lead paint to be put on buildings. The government makes me under the penalty of law to rent to tenants with children.

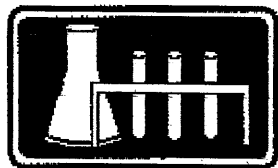
I believe it's good you are having this public hearing on the lead problem. I would like you to consider some changes in the 1999 SENATE BILL 232. I would like **limited liability** to the amount I could get sued for. I'm doing my best to get rid of the lead in my apartments and don't think I should have to risk loosing everything I own to be a landlord. I'd like the age requirement of children to be younger then 7 for lead inspections. I would like to require tenants with young children be required to give the landlord the lead readings on their children. If they are high I'd want to be able to not rent to this tenant. I want the tenants (parents) to be held accountable for keeping a clean apartment. I would like to have the tenants required to purchase and use a HEPA vacuum cleaner. I use month to month leases when I rent an apartment and don't think the landlord should have to pay for moving a tenant when doing lead repairs. I would give the tenant a 28 day notice to move and then do any required work. I don't believe apartments need to be inspected if there are no young children living there.

I didn't have anything to do with lead paint and I hope we can come up with a fair solution to the lead problem in housing.

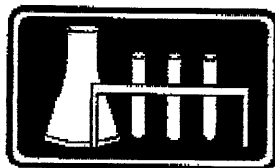

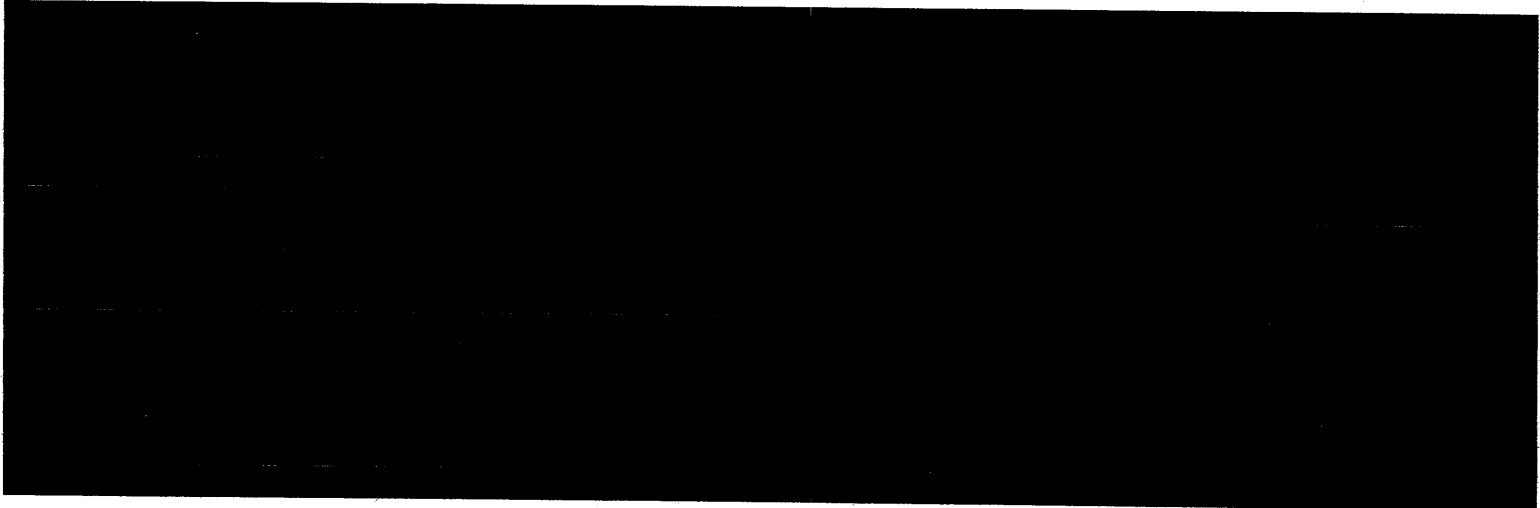

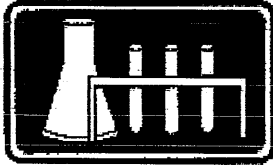
