Dear Senator Grobschmidt:

I am writing today to request that you hold a hearing on two bills, Senate Bill 241 and Senate Bill 242, that have been referred to your Senate Committee on Education. Both bills are the products of the Special Committee on the Children At Risk Program, a Joint Legislative Council Study that I chaired.

Senate Bill 241 makes changes to the Children At Risk Program that the Special Committee believed would strengthen, focus and ultimately improve the program. Senate Bill 242 provides planning grants for school districts that would help them provide extra services for retained fourth graders. Both of these bills won unanimous approval from the Special Committee and were approved for introduction by the Joint Legislative Council.

If you have any questions concerning these two bills, I would be happy to answer any that you may have. In addition, Russ Whitesel and Shaun Haas of the Legislative Council staffed the Special Committee and would be able to answer any questions.


