RE: Senate Bill 269, relating to requiring all insurers to establish internal grievance procedures, independent review of certain coverage determinations made by health benefit plans, granting rule-making authority and providing an exemption from emergency rule procedures.

DATE: November 9, 1999

On November 3, 1999, the committee held a hearing on Senate Bill 269, which requires health insurance plans to have an independent review procedure available to consumers who are denied treatment or denied payment for treatment. Attached please find paper ballot motions for introduction and adoption of Senate Amendments 1 and 2 to Senate Bill 269 and passage of Senate Bill 269 as amended.

A fiscal note from the Department of Employee Trust Funds and copies of the proposed amendments are also attached. Senate Amendment 1 (LRB a1013/1) incorporates certain changes into Senate Bill 269 that were approved by voice vote in the Assembly as amendments to Assembly Bill 518 - the companion bill to Senate Bill 269. Senate Amendment 2 (LRB a1019/1) eliminates the filing fee required under Senate Bill 269 and reduces the cost threshold for services that may be subject to independent review from \$500 to \$250.
