Dear Senator Breske:

I write to respectfully request you hold an executive session on Assembly Bill 52 as soon as possible.

I understand that many committee chairs put committee business on hold during the budget process. Although the conference committee has not concluded their work on the budget, I believe the work of the legislature can resume in the interim. In addition, since none of the Senate representatives to the conference committee sit on the Insurance, Tourism, Transportation and Corrections Committee, their schedules are not bound by the budget process at this time.

Assembly Bill 52 is an important piece of legislation. One that I believe truly will save lives and make our roads safer for everyone. AB 52 received overwhelming support in the Assembly, being passed on an 82-17 vote.
