## 1999 ASSEMBLY JOINT RESOLUTION

1 **Relating to: creating a committee of conference on 1999 Senate Bill 450, relating**  
2 **to the distribution of national forest income payments from the federal**  
3 **government and making appropriations.**

4 ***Resolved by the assembly, the senate concurring, That,*** upon the adoption  
5 **of this joint resolution by the assembly and concurrence therein by the senate, there**  
6 **is created a committee of conference on 1999 Senate Bill 450, relating to the**  
7 **distribution of national forest income payments from the federal government and**  
8 **making appropriations, to reconcile the differences between the 2 houses and to**  
9 **present its report on the bill to the 2 houses; and**

10 ***Be it further resolved, That,*** notwithstanding joint rule 3 (intro.) and (1) and  
11 **senate rule 4 (9):**

12 (1) The committee of conference on 1999 Senate Bill 450 shall consist of 4  
13 members from each house, with 3 members from each house representing the  
14 majority party in that house and one member from each house nominated by the  
15 minority leader in that house.

1           (2) The members of the committee of conference on 1999 Senate Bill 450 shall  
2 be appointed by the speaker of the assembly in the case of assembly members and  
3 be appointed by the president of the senate, without approval of the senate, in the  
4 case of senate members.

5           (3) The report by the committee of conference on 1999 Senate Bill 450 must be  
6 supported by the votes of at least a majority of the members representing each house.
