# 2001 ASSEMBLY JOINT RESOLUTION

1 **Relating to:** congratulating Marlene A. Cummings for her long-term services and  
2 wishing her well in her future endeavors.

3 Whereas, on February 25, 2001, Marlene A. Cummings will retire as Secretary  
4 of the Wisconsin Department of Regulation and Licensing; and

5 Whereas, Marlene was the original appointee of Governor Tommy G. Thompson  
6 to be the Secretary of the Department of Regulation and Licensing in 1987<sup>STET</sup> and<sup>she</sup> has  
7 served as Secretary for 14 years; and

8 Whereas, Ms. Cummings<sup>Marlene</sup> has<sup>become</sup> become a veteran state official whose agency  
9 provides professional credentials to some 250,000 service providers — from health  
10 care to real estate, <sup>and</sup> counseling to barbering and cosmetology among other professions  
11 — and <sup>whose agency</sup> reviews<sup>and</sup> disciplines these professionals when <sup>determined</sup> necessary by the department  
12 and its 24 regulatory boards; and

13 Whereas, under Marlene, the duties of <sup>the Department of</sup> Regulation and Licensing have been  
14 expanded by the Wisconsin Legislature to <sup>and</sup> license<sup>and</sup> regulate dozens of professions,  
15 including home <sup>STET</sup> inspection and marriage <sup>and</sup> family therapy<sup>STET</sup>; and


