Steve - One additional drafting request for the budget repair bill:

Establish a pharmaceutical and therapeutics committee that would advise the DHFS Secretary on prior authorization decisions. Appointed by the Governor, membership would include at least 2 practicing physicians, 2 pharmacists, an advocate for MA patients and a representative of the pharmaceutical manufacturing industry. (The DHFS Secretary should be able to appoint additional members at her discretion).

The effective date of this provision should be upon passage.
