

One of those items that has been around for a long time. Used to be \$25 for each county represented, changed in the 70's to the current \$75 and \$25. This is a throw back to the days of no office accounts. Members were given a stipend to cover costs for doing business in the district when not in session. This was to cover some of their out of pocket expenses. We now have the office accounts to reimburse for mileage, copying, phone calls, etc, which is what this money was originally intended to be used for. There have been discussions in the past about a repeal. Small amount overall, but symbolic
