

3 "SECTION 84m. 29.053 (1) of the statutes is amended to read:

4 29.053 (1) All fishing seasons on inland waters shall open on a Saturday. All
5 fishing seasons on inland waters and outlying waters shall close on a Sunday.

6 SECTION 84r. 29.404 (1m) of the statutes is created to read:

7 29.404 (1m) REMOVAL DATE. If the department establishes by order or by rule
8 a date no later than which a building, vehicle, tent, fish shanty, or similar shelter
