1 AN ACT to repeal 4.001 (2) to (5), 4.004 and 4.005; to renumber and amend
2 4.001 (1); to repeal and recreate 4.002, subchapter II of chapter 4 [precedes
3 4.009] and subchapter III of chapter 4 [precedes 4.01]; and to create 4.006 and
4 13.92 (1) (b) 3. e. of the statutes; relating to: legislative redistricting.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 SECTION 1. 4.001 (1) of the statutes is renumbered 4.001 and amended to read:
6 **4.001 Legislative redistricting; equal population districts established.**

7 Based on the certified official results of the 1980 census of population of Wisconsin,
8 as received by this state from the U.S. bureau of the census on March 23, 1981, under
9 P.L. 94-171, the This state is divided into 33 senate districts, each composed of 3
10 assembly districts. Each senate district shall be entitled to elect one member of the

1 senate. Each assembly district shall be entitled to elect one representative to the
2 assembly.

3 SECTION 2. 4.001 (2) to (5) of the statutes are repealed.

4 SECTION 3. 4.002 of the statutes is repealed and recreated to read:

5 4.002 County and municipal boundaries and wards. In this chapter,
6 reference to any county or municipality means that county or municipality as its
7 boundaries exist on August 1 of the year following the federal decennial census on
8 which the districting plans described under subchs. II and III are based.

9 SECTION 4. 4.004 of the statutes is repealed.

10 SECTION 5. 4.005 of the statutes is repealed.

11 SECTION 6. 4.006 of the statutes is created to read:

12 4.006 Definitions. In this chapter:

13 (1) "Block" has the meaning given in s. 5.02 (1q).

14 (2) "Ward" means a municipal ward in effect on August 1 of the year following
15 the federal decennial census on which the districting plans described under subchs.
16 II and III are based.

17 SECTION 7. Subchapter II of chapter 4 [precedes 4.009] of the statutes is






