1 **Relating to:** creating a committee of conference on 2001 Assembly Bill 843 and 2001
2 Senate Bill 104, the 2001 Campaign Finance Bills.

3 *Resolved by the senate, the assembly concurring, That,* upon the adoption
4 of this joint resolution by the senate and concurrence therein by the assembly and
5 notwithstanding joint rule 3, there is created a committee of conference on 2001
6 Assembly Bill 843 and 2001 Senate Bill 104, the 2001 "Campaign Finance Bills," to
7 reconcile the differences between the 2 houses, as reflected by 2001 Assembly Bill
8 843, as engrossed by the assembly, and 2001 Senate Bill 104, as engrossed by the
9 senate, and to present its report on one or both of the bills to the 2 houses; and, be

11 *Resolved, That,* notwithstanding senate rule 35 and assembly rule 40 (1),
12 neither of the bills need receive 3 readings.
