**2001-2003 Statutory Language Proposals**

Division: LAND AND FORESTRY

Bureau: MULTIPLE

Issue/Topic: CREATION OF LAND AND FORESTRY BUDGET PROGRAM

Proposed Change: The Department proposes to modify sections in the statutes that reference the Land Program, changing Land Program to Land and Forestry Program.

Explanatory Note: DNR divisions are generally funded in a budgetary program of the same title. Currently the Land Division funding is budgeted in the Land program. A new DNR division, the Forestry Division, was created in the 1999-01 biennial budget, but there are no budgetary program numbers available to create a separate budget program for it. Forestry funding is currently contained in the Land budget program. The Department proposes to expand the title of the Land Program to Land and Forestry Program, and retain Forestry funding in that Program. This change is for budgetary purposes only. The Land Division and the Forestry Division will remain as separate divisions functionally.
