**SUBSTITUTE VICE CHANCELLOR FOR
"MEDICAL AFFAIRS" IN PLACE OF "HEALTH SCIENCES"**

Language Changes Needed

Modify s. 15.407(2)(a) by modifying membership as follows:

"The vice chancellor for ~~health sciences~~ *medical affairs* of the University of Wisconsin-Madison or the vice chancellor's designee."

Background and Justification

Current statutes specify that the vice chancellor for health sciences of the University of Wisconsin-Madison be included in the membership of the Council on Physician Assistants. However, there no longer is a position at the UW-Madison titled as such, having been eliminated as part of an internal reorganization at the institution several years prior. The appropriate position title for substitution of the discontinued title to serve on the Council on Physician Assistants is *vice chancellor for medical affairs*.

This proposal would substitute the vice chancellor for medical affairs at the UW-Madison in place of the discontinued vice chancellor for health sciences at same institution to serve on the Council on Physician Assistants.
