A general purpose revenue appropriation to the department of commerce funds payments to Forward Wisconsin, Inc., for its advertising, marketing, and promotion activities and for its salary, travel, and other expenses related to its economic development promotion activities. The corporation also receives private funds. The bill creates another appropriation to the department of commerce, funded with Indian gaming revenue, for payments to Forward Wisconsin, Inc., for its activities to recruit out-of-state businesses to locate in this state.

13 appropriated under s. 20.143 (1) (bm) or (kn) on entertainment, foreign travel,
14 payments to persons not providing goods or services to Forward Wisconsin, Inc., or
15 for any other purposes prohibited by contract between Forward Wisconsin, Inc., and
16 the department.

17 **SECTION 3.** 20.143 (1) (kn) of the statutes is created to read:

18 20.143 (1) (kn) *Forward Wisconsin, Inc., business recruitment.* The amounts
19 in the schedule for aids to Forward Wisconsin, Inc., to be used for activities to recruit
20 out-of-state businesses to locate in this state. All moneys transferred from the
21 appropriation account under s. 20.505 (8) (hm) 6n. shall be credited to this
22 appropriation account.

7 communities in organizing for and obtaining new business or expanding existing
8 business and shall respond to requests which reflect interest in locating economic
9 enterprises in the state. When the secretary considers it appropriate, the
10 department shall refer requests for economic development assistance to Forward
11 Wisconsin, ~~inc.~~ Inc., and shall attempt to prevent duplication of efforts between the
12 department and Forward Wisconsin, ~~inc~~ Inc.

17 establish and implement a nationwide business development promotion campaign
18 to attract persons interested in locating new enterprises in this state and to
19 encourage the retention and expansion of businesses and jobs in this state. Funds
20 may be expended to carry out the contract only as provided in s. 16.501.
