DATCP -- TRADE AND CONSUMER PROTECTION

Food Advisory Council

Motion:

Move to require DATCP to create a food advisory council for the purpose of focusing on issues relating to providing a safe and wholesome food supply in Wisconsin, including the following: (a) recall information; (b) the Wisconsin food code; (c) food safety concerns and communications; (d) training; (e) Department and industry partnerships; (f) enforcement and inspection; and (g) other issues related to the food industry.

Require the Council to meet at least quarterly and that the Council consist of (a) consumer representatives; (b) retail and wholesale grocery representatives; (c) DATCP staff; (d) members of academic institutions; (e) representatives from the federal Department of Health and Human Services; and (f) representatives of the food industry or a food industry association.
