TEMPORARY ASSISTANCE FOR NEEDY FAMILIES

Early Childhood Excellence Initiative

Motion:

\$ 50,000

Move to specify that ~~\$30,000~~ in 2002-03 from the temporary assistance for needy families (TANF) block grant funds designated for the early childhood excellence initiative would be provided to an agency in Stevens Point that provides high quality early childhood education services, including music appreciation, gymnastics, swimming lessons, foreign language experience, creative movement to music, computer education, field trips, cooking experiences, family visits, family panels, videocam services, a family resource library and parent workshops. Specify that the funds would be used to subsidize child care for recipients based upon their ability to pay.

Note:

Under current law, DWD is required to distribute \$7,500,000 annually to develop at least 5 early childhood centers for children who are eligible for assistance under the TANF program. Grant recipients are required to contribute matching funds equal to 25% of the amount awarded.

The Governor's budget bill would provide \$7,500,000 in 2001-02 for the early childhood excellence initiative to fulfill current contractual obligations and would provide \$7,500,000 in 2002-03 for new grants. The motion would designate \$30,000 from the 2002-03 to subsidize child care for recipients based upon their ability to pay.
