1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 116, line 18: increase the dollar amount for fiscal year 2001-02 by  
3 \$150,000 and increase the dollar amount for fiscal year 2002-03 by \$150,000 to  
4 increase funding for the purposes for which the appropriation is made.

5 2. Page 116, line 21: delete lines 21 and 22.

6 3. Page 299, line 23: delete "grant" and substitute "grants".

7 4. Page 299, line 24: after "(1)" insert ", (10fk), (11pk) ~~and~~".

8 5. Page 300, line 16: delete lines 16 to 21.

9 6. Page 396, line 20: delete lines 20 to 22.

1           **7.** Page 1162, line 8: delete lines 8 to 10.

2           **8.** Page 1326, line 5: after that line insert:

3           “(10fk) GRANT TO FLORENCE COUNTY KEYES PEAK RECREATION CENTER. From the  
4 appropriation under section 20.143 (1) (kj) of the statutes, as affected by this act, the  
5 department of commerce shall provide a grant of \$50,000 in the 2001–03 biennium  
6 to the Florence County Keyes Peak Recreation Center for a construction project. The  
7 department of commerce shall enter into an agreement with the grant recipient that  
8 specifies the uses for the grant proceeds and reporting and auditing requirements.

9           (11pk) GRANTS TO POTOSI BREWERY FOUNDATION.

10          (a) In this subsection:

11           1. “Department” means the department of commerce.

12           2. “Secretary” means the secretary of commerce.

13          (b) In the 2001–03 fiscal biennium, the department shall make a grant of  
14 \$30,000 and a grant of \$120,000 from the appropriation under section 20.143 (1) (kj)  
15 of the statutes, as affected by this act, to Potosi Brewery Foundation for the purposes  
16 specified in paragraph (c) if all of the following apply:

17           1. Potosi Brewery Foundation submits a plan to the department detailing the  
18 proposed use of the grant, the plan is in compliance with the uses specified in  
19 paragraph (c), and the secretary approves the plan.

20           2. Potosi Brewery Foundation provides matching funds of \$120,000 for the  
21 project.

22           3. Potosi Brewery Foundation enters into a written agreement with the  
23 department that specifies the conditions for the use of the grant proceeds, including  
24 reporting and auditing requirements.

1 4. Potosi Brewery Foundation agrees in writing to submit to the department  
2 the report required under paragraph (d) by the time required under paragraph (d).

3 (c) The grant of \$30,000 under this subsection shall be used for development  
4 of a historic structure report and the grant of \$120,000 under this subsection shall  
5 be used for development of a marketing plan, restoration and salvage of the brewery  
6 structure, and restoration project fundraising.

7 (d) If Potosi Brewery Foundation receives a grant under this subsection, it shall  
8 submit to the department, within 6 months after spending the full amount of the  
9 grant, a report detailing how the grant proceeds were used. )) ←

10 (12fk) GRANT TO FORWARD WISCONSIN, INC. Notwithstanding section 560.07 (3)  
11 (b) of the statutes, from the appropriation under section 20.143 (1) (kj) of the statutes,  
12 as affected by this act, the department of commerce shall provide a grant of \$100,000  
13 in fiscal year 2002-03 to Forward Wisconsin, Inc., for its activities related to  
14 attracting businesses to the state. Forward Wisconsin, Inc., shall expend the grant  
15 proceeds in adherence with the uniform travel schedule amounts approved under  
16 section 20.916 (8) of the statutes, as affected by this act, and may not expend the  
17 grant proceeds on entertainment, on foreign travel, on payments to persons not  
18 providing goods or services to Forward Wisconsin, Inc., or for other purposes  
19 prohibited by contract between Forward Wisconsin, Inc., and the department of  
20 commerce. The department of commerce shall enter into an agreement with  
21 Forward Wisconsin, Inc., that specifies the uses for the grant proceeds under this  
22 subsection and reporting and auditing requirements."
