



## 2001 SENATE BILL 30

January 26, 2001 - Introduced by Senators PLACHE, BURKE, MOORE, MOEN and SCHULTZ, cosponsored by Representatives LADWIG, STARZYK, J. LEHMAN, COGGS, POCAN, TOWNSEND, BERCEAU, MILLER, ALBERS and WASSERMAN. Referred to Committee on Economic Development and Corrections.

1     **AN ACT to amend** 302.01 of the statutes; **relating to:** renaming the women's  
2     minimum security correctional facility at Union Grove, Racine County.

### *Analysis by the Legislative Reference Bureau*

Currently, the women's minimum security correctional facility at Union Grove, Racine County, is named the Robert E. Ellsworth Women's Center. This bill names that facility the Cordelia Harvey Women's Center. Cordelia Harvey was the spouse of Louis P. Harvey, the 7th governor of Wisconsin.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3     **SECTION 1.** 302.01 of the statutes is amended to read:

4 The penitentiary at Taycheedah is named "Taycheedah Correctional Institution".  
5 The medium security penitentiary at Plymouth is named "Kettle Moraine  
6 Correctional Institution". The penitentiary at the village of Sturtevant in Racine  
7 county is named "Racine Correctional Institution". The medium security  
8 penitentiary at Racine is named "Racine Youthful Offender Correctional Facility".  
9 The resource facility at Oshkosh is named "Wisconsin Resource Center". The  
10 minimum security women's correctional facility at the village of Union Grove in  
11 Racine County is named "Cordelia Harvey Women's Center." The institutions named  
12 in this section, the correctional institutions authorized under s. 301.16 (1n) and (1v),  
13 correctional institution authorized under 1997 Wisconsin Act 4, section 4 (1) (a),  
14 correctional institution authorized under s. 301.046 (1), correctional institution  
15 authorized under s. 301.048 (4) (b), minimum security correctional institutions  
16 authorized under s. 301.13, the probation and parole holding facilities authorized  
17 under s. 301.16 (1q) and state-local shared correctional facilities when established  
18 under s. 301.14, are state prisons.
