It went through the rule-making process and was ready to be adopted by the Examining Board of Social Workers, Marriage and Family Therapists and Professional Counselors. At the time of final adoption it was discovered that a change that should have been made was not made. Thus, the board is now proceeding with the correct language.

The Social Worker Section of the Examining Board of Social Workers, Marriage and Family Therapists and Professional Counselors issues four different types of social worker certification, based on an applicant's education and experience. An individual who has received one type of certification may later apply for another type. All applicants are currently required to take and pass a state jurisprudence examination. The proposed change would eliminate the need to retake the state jurisprudence examination if the applicant passed the examination within the previous five years.

TEXT OF RULE

SECTION 1. SFC 1.05 (7) is created to read:

SFC 1.05 (7) An applicant for certification as a social worker, advanced practice social worker, independent social worker or independent clinical social worker, need not take part II of the examination if within the 5 years preceding the date of application, the applicant took and

passed part II in the process of applying for and receiving another social worker certification from the section.
