**Good morning and thank you for the opportunity to  
discuss the important matter of enacting SB-47 into law  
which would establish a standardized seat belt law in  
Wisconsin..**

**I'm John Evans, Director of the Wisconsin  
Department of Transportation's Bureau of  
Transportation Safety with Lt. Lee McMenemy of the  
Wisconsin State Patrol. We are here this morning to  
testify in support of SB 47.**

**Seatbelts work. They are the most effective and  
cost effective means we have today of reducing fatalities  
and serious injuries when traffic crashes occur.**

Lap and shoulder belts, when used properly, reduce the risk of fatal injury to front seat passenger car occupants by 45 percent and the risk of moderate-to-critical injury by 50 percent. For light truck occupants, the effectiveness increases to 60 and 65 percent.

Currently in Wisconsin 65 percent of occupants wear seatbelts. That means that after 13 years of experience with Wisconsin's secondary enforcement seatbelt use law, nearly two out of every five motorists still do not buckle up. There are still simply too many people putting themselves in harms way by not buckling up.

If a standardized belt law is passed and we get the average increase other states have experienced with the

**new law, we could have 77 percent, or more than three of four, Wisconsinites wearing belts and would save many more lives and prevent many more serious injuries.**

**It is estimated that here in Wisconsin we would save 67 lives per year - and prevent approximately 1,700 injuries annually by increasing belt use by these 15 percentage points.**

**Opponents of seatbelt use laws frequently claim that a person has the “right” not to use a seatbelt because the only one who is likely to be injured as a result is oneself. In fact, this is untrue.**

**Unbelted vehicle occupants frequently injure other occupants in a crash. Your ability to control your**

**vehicle is significantly diminished in a crash if you are unbelted.**

**Children riding with unbelted adults are only one-third as likely to be buckled up themselves, as are children riding with belted adults. And, the cost of increased deaths and injuries associated with failure to wear a seatbelt is borne by all of us.**

**NHTSA has found that 85 percent of the median costs of crash victims is paid with public funds.**

**Traffic crashes cost huge amounts of money. Each year in the United States traffic crashes claim about 42,000 lives.**

**These crashes cost Americans \$150 billion in economic costs, including \$17 billion in medical and**



**emergency expenses, lost productivity and property loss.**

**Currently National Safety Council estimates that each traffic death costs society \$993,300. Last year in Wisconsin we killed 801 people on our roadways. This amounts to \$796 million dollars; Injuries cost \$943 million dollars; and, property damage \$921 million dollars. Each year In Wisconsin we experience a total economic loss from traffic crashes of \$2.7 billion dollars.**

**In 1996 we did a study of hospital charges associated with vehicle crashes as it relates to seatbelt use.**

**It was concluded that for people that were involved in crashes who were not wearing seatbelts, the average**

**hospital charges would have been \$6,700 per person lower if they had been belted.**

**This would have resulted in an overall savings of almost \$10 million dollars of hospital and medical costs alone.**

**The vast majority of the population of our country expresses positive attitudes about seatbelt use. The National Highway Traffic Safety Administration found, however, that when they asked how often they wear their belts, that 76 percent of drivers say they do so “all the time” when driving.**

**Yet, almost 10 percent of these “all the time” users also indicate that they failed to buckle up at least once while driving in the past week.**

**For those who report wearing seatbelts “most of the time” (12 percent of the drivers), almost 70 percent say they did not wear seatbelts while driving during the past week.**

**This underscores the fact that many people fall into the category of “Part time” users, even though they view themselves as full time users.**

**In fact, part time users appear to substantially outnumber non users. Having a law will remind drivers to do what it is they already want to do.**

**Sixty-eight percent of drivers say the reason they use belts is to avoid injury - not because they are afraid of being stopped by a law enforcement officer.**

**“Seatbelts Save Lives” is more than just a highway safety slogan, it is a highway safety reality.**

**Unfortunately, not enough drivers and passengers heed the seatbelt message. This has resulted in consequences that have been nothing short of tragic for all of us.**

**Experience in other states clearly indicates that giving law enforcement officers the ability to stop a motor vehicle when they notice an occupant not wearing a seatbelt can increase overall belt use to more acceptable, life-saving levels.**

**For that reason, The Wisconsin Department of Transportation supports Senate Bill 47.**

**We certainly encourage you to do likewise.**

**Because it is a matter of common sense and is simply  
the right thing to do.**

Good morning. I am Lieutenant Lee McMenammin of the Wisconsin State Patrol. I am here on behalf of the State Patrol and the Department of Transportation to testify in support of SB 47 – primary safety belt enforcement.

The use of safety belts is often the best defense an occupant of a vehicle has to prevent death or serious injury. According to the United States Department of Transportation a person wearing a safety belt increases their chances of avoiding death and injury by up to 50 % . On a weekly basis personnel from the Wisconsin State Patrol respond to traffic crashes involving personal injury or death that may have been avoided or minimized had safety belts been used. The goal of primary enforcement as proposed in SB 47, is not to write more citations, but to save lives.

Surveys have identified persons age 16-34 years as those least likely to use safety belts. Last year 68% of those killed in Wisconsin traffic crashes were not wearing a safety belt. Adult use of safety belts set an example for children and passengers on how to drive safely. Nationwide research shows

that when an adult driver is buckled up, child restraint use is 94%. However, when a driver is unbuckled, child restraint use drops to only 30%. Wisconsin Law requires Children under the age of 4 years old to be properly secured in a child safety seat. Wisconsin law also requires children ages 4 through 7 years old to be buckled in a child safety seat or safety belt. Enactment of SB47 would compliment child restraint law already in effect. The law enforcement community in general, and the State Patrol in particular, is hopeful that primary safety belt enforcement will become a "self-compliant" law. That is, we hope that the strong stand that the law will take in regards to safety belt use will educate motorists and encourage them to use safety belts because they know that mandatory safety belt use is the law, and that it does, literally save lives. Obtaining a driver's license is a privilege, and with that privilege comes the responsibility to obey traffic regulations for the sake of personal and public safety.

SB 47 will not change any of the safety belt use exemptions currently identified in statutes for such vehicles as taxi cabs, rural mail carriers, and land survey crews. It will not greatly increase the penalty for a safety belt violation, current law calls for a forfeiture of \$10.00, SB47 would call for a first offense forfeiture of \$25.00, and the exemption of safety belt violations from additional costs and fees attached to other traffic violations still remains. Nor will law enforcement activities change. Law enforcement will continue to enforce safety belt use, as required by law, as part of their focus on highway safety. The enactment of SB 47 will simply assist law enforcement in protecting and respecting the people they serve.

There are currently 4,450,000 registered vehicles and 3,710,000 licensed drivers in Wisconsin traveling more than 55,500,000 miles each year. With that many vehicles and motorists on our roadways, it is important to keep our drivers and passengers as safe as possible, and the enactment of SB 47 is one tool in the pursuit of that goal.

On behalf of Sacred Heart Hospital, I would like to strongly endorse passage of a primary safety belt law.

Wisconsin has fallen behind the national usage rate, which is now at 68%. In most of the 18 states with a primary law, the usage rate is over 80%. It has been eight years since California has passed such a law (the first to do so) and the front seat belt use rate in California is at 90% compared to an estimated use rate of 62% in Wisconsin.

As the Administrator of Sacred Heart Hospital I am committed to preventative care. Passage of SB 47 will result in a 10 – 15 point increase in the safety belt usage rate, thereby preventing vehicle occupants from needless death and injuries not to mention the savings of millions of dollars in lost wages and hospital costs.

Currently, a law enforcement officer can cite a driver for singularly violating every other traffic safety law except the belt law. It is time to elevate this lifesaving law to the level of enforcement of all other laws and stop preventable deaths and injuries on Wisconsin's roadways.

The need to pass this legislation this year is especially poignant considering that last year, 802 people - the highest number since 1987 - were killed on Wisconsin's roadways and two-thirds of those people were unbelted. Safety experts predict that a standard enforcement belt law will prevent approximately 67 fatalities and 1,700 injuries every year.

Your support of this important safety legislation will result not only in preventing tragedies on the roads, but also in saving millions of dollars every year. A 1996 report to Congress on the effectiveness of safety belts found the average charge for unbelted drivers admitted to an inpatient facility as a result of a crash injury was 55% greater than the average charge for those belted. Safety experts predict that as much as \$115 million would be saved annually in medical costs and lost time for the state, businesses and people of Wisconsin.

Additionally, research shows that if a driver is unbuckled, 70 percent of the time children riding in that vehicle are also unbuckled. Conversely, when a driver is buckled, 94 percent of the time children riding in that vehicle are buckled. When adults do not wear their belts, they are sending a deadly message to their children that it is okay not to use a safety belt.

Currently, 52 percent of the nation is covered by standard enforcement belt laws, including neighboring states Michigan and Iowa as well as fifteen other states and the District of Columbia. The average safety belt use rate in states with a standard enforcement law is 17 percentage points higher than in states with secondary enforcement. Maryland's safety belt use went up 13 percent points in just over one year and the District of Columbia's use rate rose 24 percent points. Other standard enforcement states such as California, New Mexico, Oregon, and North Carolina have use rates above 80%. While belt use rates across the country are increasing, Wisconsin's safety belt usage of 65% remains below the national average.

Advocates urges you to add Wisconsin to the list of states that have acted to make their roads safer -- vote in support of SB 47.
