**Assumptions Used in Arriving at Fiscal Estimate**

The bill would change certain mailing requirements on zoning notices from counties to towns. The number of notices currently requiring registered mail by counties is not usually accounted for separately in local budgets. However, the use of regular mail would constitute a savings per item of several dollars to counties multiplied by some varying number of items. The new requirement for town clerks to send a signed and dated admission of service in lieu of receiving registered mail would also have a cost to towns, however the cost is indeterminate.
