



2003 ASSEMBLY RESOLUTION 39

March 10, 2004 - Introduced by COMMITTEE ON RULES.

1 **Relating to:** establishing special orders of business for Thursday, March 11, 2004.

2 ***Resolved by the assembly, That:***

SECTION 1. Special order scheduled. The following proposals shall be special orders of business on Thursday, March 11, 2004, at the times shown:

- (1) At 9:00 a.m., 2003 Senate Bill 384, relating to: authorizing technical college districts to issue revenue bonds for the purpose of providing services and facilities to businesses, granting rule-making authority, and making an appropriation.
- (2) At 9:01 a.m., 2003 Senate Bill 508, if the bill is in the Assembly, relating to: minimum wage and overtime pay exemptions for providers of companionship services.
- (3) At 9:02 a.m., 2003 Senate Bill 451, relating to: appropriating money to technical college districts for the Wisconsin Advantage Jobs Training Program and making an appropriation.
- (4) At 9:03 a.m., 2003 Senate Bill 512, relating to: the property tax exemption for property that is leased as residential housing.
- (5) At 9:04 a.m., 2003 Senate Bill 253, relating to: independent charter schools established by University of Wisconsin institutions and college campuses.
