AB78 on Memorial Day Holiday

The Wisconsin Innkeepers Association, representing over 1,150 hotels. motels, resorts, inns and bed & breakfasts throughout Wisconsin, respectfully asks this committee to oppose AB78, which establishes the Memorial Day holiday for state employees as May 30 whenever that day falls on a weekday, or the following Monday if it falls on a weekend.

Changing a holiday to differ with the date honored by most private businesses would:

- * Cause confusion
- * Result in a lack of state services on a day citizens anticipate service
- * Not allow state employees to share the holiday with their family
- * In some years result in a holiday in the middle of the week, when a convenient 3-day weekend would be appreciated more.

This change would also negatively impact Wisconsin's tourism economy, one of the primary sales-tax generating industries for the state. Replacing a 3-day weekend where many Wisconsin families enjoy a leisurely getaway, with a single mid-week day will cause a reduction in revenue for both the tourism industry and the state.

Please oppose AB78.
