Attached is a diagram of how we would like the room arranged for the Joint Legislative Audit Committee meeting on Friday.

As noted in the diagram, we need one head (4 tables put together as we discussed). 15 chairs will need to be placed in conference Room 3 at this head table, all chairs facing the other conference rooms. We need three microphones at the head table. One microphone should be placed in the middle of the table and one microphone at each of the table separations. In my diagram "M" stands for microphone.

In front of the head table we need a screen against the wall in-between the windows (with curtains pulled) at roughly the room divider location. We also need an AV cart, one table, three chairs facing the head table and a microphone in the middle of the room just inside Room 3.

The straight parallel lines indicate where we would like single chairs lined up in two rows. These chairs should all face the head table. We need seating for 75 people in this audience section.

Lastly, we need a single table at the entrance to Room 1 where we can put information and hearing slips for hearing attendees.



Joint Legislative Audit Committee to hold Public Hearing on State Fair Park Evaluation

(Madison)... On Friday, November 7, 2003, the Joint Legislative Audit Committee, co-chaired by Rep. Suzanne Jeskewitz (R-Menomonee Falls) and Sen. Carol Roessler (R-Oshkosh), will hold a public hearing on the State Fair Park Evaluation, report 03-11, released by the non-partisan Legislative Audit Bureau on September 11, 2003.

The Legislative Audit Bureau's report raises several concerns about the Park's finances. In addition, the Legislative Audit Bureau was unable to conduct the annual financial audit that is required by statutes because State Fair Park was unable to compile complete and accurate financial information. Due to the fiscal picture presented in the evaluation, the co-chairs are expected to ask State Fair Park officials: 1) why accurate and complete financial statements were not available to state auditors and when will they be made available; 2) what changes in their business planning and practices can be made to turn the park around financially; and 3) how the State Fair Park's mission can be fulfilled given the current fiscal situation of the park.

The Legislative Audit Bureau will present its findings and then State Fair Park officials will have an opportunity to respond. The hearing will be open to the public for comment.





- When will the FY 2002-03 financial statements be available to the Legislative Audit Bureau?

Management Issues:

- The chief executive officer's contract was just extended. When was that decision
 made and what are the specific terms of that contract extension? Did the CEO receive
 a salary increase?
- Were proper procedures followed in noticing this Board meeting to the public?

Milwaukee Mile:

- The 2003 racing season is complete. Did the 2003 racing activities generate a profit? What is the profit or loss projection for the 2004 racing season?
- Considering the size of State Fair Park's deficit, why, at its last meeting, did the State Fair Park Board decide to move forward with \$1.8 million in bonding for additional Milwaukee Mile improvements?

- As not-for-profit organizations, the Exposition Center and the Pettit Center have the independence and flexibility that State Fair Park as a whole is now seeking. However, that independence has not allowed those entities to meet original expectations. For example, the Exposition Center has not received naming rights revenue from a large donor. Why do you believe greater flexibility will help the fairgrounds?
- Should an authority be created, how would legislative oversight be maintained?
 Would, for example, auditors from the Legislative Audit Bureau have access to your records?
- Can you assure us that all debt service payments will be made as scheduled?

Among the strengths of Wisconsin has always been a foundation in industry, agriculture and tourism. All of these areas are impacted positively by the agricultural component of Wisconsin State Fair and the World Beef Expo. The agricultural division has made great strides in restructuring its fiscal profile over recent years. Agriculture is a dominant reason a high percentage of attendees come to the Wisconsin State Fair and therefore a big component of the most financially sound enterprise connected to Wisconsin State Fair Park.

The World Beef Expo, an enterprise held at the same time as Harvest Fair, has made great strides toward fiscal soundness. Harvest Fair has established a track record of net revenue generation. World Beef Expo strengthens the Harvest Fair through the provision of a greater connection to agriculture and as such is partially responsible for that fiscal success.

I work specifically with World Beef Expo as the coordinator of an Intercollegiate and Youth Livestock Judging Contest. This event, having finished its 3rd year, has consistently drawn attendance from over 13 colleges and universities from the Midwest extended and a large number of youth contestants. This past year we featured attendance by universities from as far away as California, Ohio, and Tennessee. Over 200 youth participated in this single component of the much larger World Beef Expo. The livestock judging component, from an intercollegiate competition standpoint, was added to the World Beef Expo to bring greater visibility to Expo itself, the State of Wisconsin and the high quality of livestock industry featured at World Beef Expo. World Beef Expo chose to host the livestock judging contest in what has become a symbiotic relationship. Each is strengthened through the other. The University of Wisconsin further supports these activities through cooperative efforts of all three agricultural campuses in the UW System.

Livestock judging has long been recognized for its value in youth development. At the collegiate level, livestock judging emphasizes decision making, sound-logic based reasoning, articulation of thought and team building. It's a tremendous addition to education of young people ranging from 4-H and FFA youth through young adult college seniors.

As your committee deliberates the future of Wisconsin State Fair Park, I trust you will maintain an interest and emphasis on Agriculture and its importance to our State's youth and its culture.

Dear Senator Roessler, Senator Darling and Representative Jeskewitz: I am writing this letter to address some topics which were put forth in the Milwaukee Journal Sentinel article regarding last Friday's meeting with State Fair Park officials. I had been employed by the Milwaukee Mile for the past 11 1/2 years. I was among the first employees brought on board when Carl A. Haas Racing was granted the racing contract in Spring 1992. In mid Sept. I was let go by Joe Chrnelich and Mark Perrone. The reasons for my termination were budget reasons and a reorganization of race and Fair Park personnel. It is my belief that there was certainly more involved, but that is not pertinent to this correspondence. I am not writing this letter as a disgruntled employee, rather this note is written on behalf of the many great volunteers and racing fans that have supported the Milwaukee Mile for many years.

If the Legislative Committee does not have accurate financial documents for 2001-02 or 2002-03 then how does anyone know what the true cost was of the State Fair Park Board buyout of the Carl Haas racing contract? Hopefully you are aware that the buyout consisted of a \$250,000 cash settlement and "excusing" CAH racing of all previous debt obligations. Was this debt \$100,000, \$500,000, \$1,000,000, \$1,500,000? Has this ever been quantified? In the matter of compensation let me note that in addition to Mr. Perrone's \$150,000 salary he will be receiving 2 1/2% of all racing revenues. This is not revenue above a certain agreed upon level but all revenue!!! Additionally, he is reimbursed for expenses (meals, gas, etc.). Also, one of the few sponsorships that Mr. Perrone brought forward was an agreement with the Residence Inn in Brookfield which provides for his lodging as well as Chuck Kosich'. Again, you should be aware that both Mr. Perrone and Chuck Kosich do not reside in or within commuting distance of the racetrack. Mr. Perrrone lives in Mass., Mr. Kosich lives in Houston.

With regards to "industry standards" for compensation it should be noted that these standards are being compared to racing facilities that are profitable and that host a Winston Cup NASCAR event. Thus, this is not an "apples to apples" comparison.

With regards to the Milwaukee Mile doubling its number of races in 2004 from two to four let me ask "How does that guarantee profitability?" Has anyone

ever produced a pro forma for the new races? If they have, it would be curious to see what the attendance and sponsorship projections are. Additionally, Mr. Chrnelich notes that attendance rose 20% in 2003. In light of the fact that the Milwaukee Mile was celebrating its' 100th Anniversary, hosted the first ever CART race under lights, and had a brand new Grandstand to offer its fans-20% doesn't seem to be much to crow about. This is akin to someone saying their stock rose 50% from 2 to 3 but not telling them that they bought at 50!

Lastly, it should also be noted that Mr. Perrone is involved in some outside interests. He was involved in procuring the title sponsorship (Golden Korral) for the Atlanta Motor Speedway for its NASCAR race next season. This while the Milwaukee Mile has no title sponsors for its racing events. Additionally, it is believed that he and another staff member were in Bristol,TN in mid August for the press conference announcing the sponsorship on Milwaukee Mile/State expense. Lastly, I would suggest that there has been no due diligence with regards to Mr. Perrone's past. Specifically, you should be aware that he had been charged with felony tax evasion charges and convicted of misdemeanor charges resulting in \$10,000 fine, court costs, two years probation and not being allowed to own or possess a firearm. He is now in a position of fiduciary responsibility for an agency of the State of Wisconsin.

I hope some of this information sheds a little light on what is going on at the State Fair Park as it relates to the Milwaukee Mile. If you need any explanation of any of the aforementioned feel free to contact me.
