Testimony of LaVerne Ausman, Executive Director Western Wisconsin Renewable Energy Cooperative January 13, 2004

Mr. Chairman and Members of the Agriculture, Financial Institutions & Insurance Committee

The benefits of ethanol to the environment and the ethanol industry to the state have been well established. I will not dwell on that but to say that at a time when we are concerned about manufacturing moving off shore this not only builds manufacturing here but also reduces what we are now importing.

Now to the specifics of SB 343. The Western Wisconsin Renewable Energy Co-op (WWREC) goes on record in support of Senate Bill 343 in principle and wishes to express our appreciation for this initiative. We would like to share some comments on some specific provisions.

The change to a sum sufficient appropriation is very helpful in financial forecasting and financing the debt portion of a new plant. We regard that as a very important provision.

The basic public policy is to encourage ethanol production. Front loading the payments by declining levels every two years is good public policy and good for the developers. The startup costs are significant and help on the front end is most important.

Reducing the current payment eligibility from 15,000,000 gallons annual production to 12,500,000 seems to be going in the wrong way. Almost all ethanol plants under construction today are much larger than this and existing plants are expanding. It seems to be counterproductive to encourage small plants given the economics of the industry. If the issue were to control the potential budget exposure then I would ask that you look at the rate per gallon but increase the gallons. Limiting the out years could also be considered in over all budget exposure if that becomes an issue.

Thank you for your consideration and I look forward to working with you on this issue.
