# **BILL HISTORY**

Assembly Bill 341 was referred to the Assembly Committee on Children and Families on May 13, 2003. A public hearing was held on June 26, 2003. On August 12, 2003 the Assembly Committee on Children and Families recommended passage on a vote of 7-0. On November 17, 2003, the Joint Finance Committee recommended passage on a vote of 15-0. On January 20, 2004 the Assembly recommended passage on a voice vote.

On January 21, 2004 AB 341 was referred to the Senate Committee on Health, Children, Families, Aging and Long Term Care. A public hearing and executive session were held on February 12, 2004.

The Committee recommended passage on a vote of 9-0.

# LRB ANALYSIS

## Current Law:

Under current law, the fee for a marriage license, which is paid to the county clerk, is \$49.50, but a county board may increase the fee by any amount. Of the amount of the fee, the state receives \$25 and the county retains the remainder, which is \$24.50 if the county board does not increase the fee. Of the amount retained by the county, \$20 must be used for its family court counseling services, under which mediation services are provided to the parties in an action affecting the family, such as a divorce, when custody or physical placement of a child is contested.

Current law also provides funding for services related to domestic violence through the domestic abuse assessment, which a court imposes when sentencing a person for committing a domestic abuse offense. The Department of Health and Family Services uses money from the assessment to award grants to organizations and agencies that provide those services.

# **Proposed Changes:**

This bill does not change the requirement that a county must use \$20 of the portion of the marriage license fee that it keeps for its family court counseling services, but the bill specifically authorizes a county to use any or all of the remaining amount that it keeps for education, training, or services related to domestic violence.

This bill also increases the domestic abuse assessment from \$50 to \$75 per offense.

# FISCAL EFFECT

## **Department of Health and Family Services**

The bill is estimated to increase the amount of program revenue received for domestic abuse grants to \$569,930. Therefore, changing the domestic abuse assessment from

AB 341 Letter to Joint Finance...

Dear Senators;

Assembly Bill 341 has been scheduled for action on today's Senate floor calendar. This bill is a critical piece of legislation for local domestic violence programs. It is supported by the WI Coalition Against Domestic Violence, the Governor's Council on Domestic Abuse, and local domestic abuse programs throughout WI.

During the past two years, local domestic abuse programs have lost unprecedented levels of funding. Federal sources have been cut (VOCA, VAWA, and FVPSA), Wisconsin reduced funding for domestic abuse programs by 3%, local funders (counties and cities) have passed on cuts in shared revenues to domestic abuse programs, and charitable giving is at an all time low causing many foundations, such as the United Way, to reduce funding levels for local programs.

This bill can help stabilize funding for domestic abuse programs in two ways:

1-It increases the domestic abuse penalty assessment, an assessment paid by CONVICTED domestic abuse offenders, by \$25. The domestic abuse penalty assessment has existed since 1989 and has never been raised in 15 years. The assessment collections are treated as program revenue by the state and are funneled directly back to local domestic abuse programs as a portion of the state's Domestic Abuse grant program administered by DHFS. It is anticipated that raising the assessment could generate an additional \$200,000 in revenues for domestic abuse services. Although this amount is not even equal to the 3% state funding cut experienced last budget, much less the rest of the funding losses, it will certainly be helpful in offsetting some of the losses suffered by these critical programs.

2-It opens the possibility for counties to utilize some of the funds they retain from marriage license fees to fund local domestic abuse services. It does not raise marriage license fees nor does it require counties to use the funds for domestic abuse services. It merely creates the possibility. Local government will still decide how best to spend those dollars and if they believe funding domestic abuse services is a priority, they can use marriage license revenues to do so.

I have attached a memo that I prepared for Joint Finance on this issue. I hope it will provide any additional information that you find necessary in evaluating your decision to hopefully support this bill. This bill has passed the Assembly Committee on Children and Families unanimously, passed Joint Finance unanimously, passed the Assembly unanimously, and passed the Senate Committee on Health, Children, Families, Aging and Longterm Care unanimously. It is unopposed by any organization (please note: the Ethics Board website does note that Dean Medical and St. Mary's Hospital oppose this bill...we have been informed that was an erroneous entry by those organizations who believed they were registering against AB 314. Thus far the Ethics Board has not removed this error from the website however, Michael Heifetz, lobbyist for both organizations, assures us that Dean and St. Mary's have no opposition to AB 341).

Assembly Bill 341 is scheduled for review by the Committee on Joint Finance on Monday, November 10, 2003. On behalf of the Wisconsin Coalition Against Domestic Violence (WCADV), a non-partisan, statewide membership program representing domestic violence programs and victims and their children, I urge you to support the language offered in this bill.

Currently, 58 non-profit agencies and 11 tribes receive funding from the Department of Health and Family Services (DHFS) to provide services to victims of domestic abuse and their children at over 100 program sites in Wisconsin. Domestic abuse services are offered in all 72 counties. In the past five years, domestic abuse programs have experienced a more than 30% increase in requests for services. Yet, there have been no significant increases in state funding to domestic abuse programs since 1997. Instead in 2003, for the first time, the state cut funding to domestic abuse programs by three percent in response to a larger state budget crisis.

Wisconsin domestic abuse programs provide direct services to well over 30,000 women, children and men each year, a number that has been steadily increasing. And while public and governmental support for services to families experiencing domestic violence has steadily increased, the current funding climate puts these critical services at high risk for reduction or elimination altogether. If the state decrease of 3% was the only funding cut that domestic abuse programs were facing, such a reduction could be absorbed by many programs. However, local domestic abuse programs are now facing funding cuts from many of their long-time funding sources despite the dramatic increases in the numbers of persons needing services. At this time, we are anticipating that local domestic violence programs will experience an overall loss of between 20-30% of their funding within the next year. Reductions in federal funding sources (Victim of Crime Act, Violence Against Women Act, Family Violence Prevention and Services Act, and Housing and Urban Development); as well as the 3% state reduction; the loss of \$750,000 in federal funds to the Refugee Family Strengthening Projects; and cuts from County/City government, United Way and dramatic decreases in charitable giving contribute to this funding crisis. The grid below illustrates the reductions that local domestic violence programs are experiencing. While the grid indicates the losses are "anticipated", WCADV is now being flooded with calls from local programs as they receive word of vastly reduced funding

levels from local governmental and foundation funding sources. The losses that were once anticipated are now becoming a stark reality for many programs.

Assembly Bill 341 provides a practical solution, at least in part, to the funding crisis now facing local domestic abuse providers. WCADV hopes that the funding reductions do not lead to the elimination of domestic violence services in any Wisconsin communities. However, we do know that services will be changed by being so greatly reduced. AB 341 will provide an opportunity to replace some of those funding losses. Victims of domestic violence and their children count of services being there in their communities. WCADV is hopeful that you will look favorably upon AB 341 so that those families experiencing abuse receive the support they so critically need.

- AB 341 authorizes counties to use the marriage license fee for purposes related to domestic violence and increasing the assessment imposed on persons convicted of domestic abuse offenses.
- This bill does NOT require counties to use the \$4.50 of the \$24.50 obtained for domestic abuse education, etc purposes. It simply *clarifies* that that \$ can be used for these purposes.
- The only thing that this bill changes from current law is that 1) it clarifies that \$ can be used for dom violence (which isn't really a change) and 2) raises domestic abuse assessment from \$50-\$75 for each offense.
- Again...this bill in no way mandates how the county clerk should use this \$.

SUBJECT: Assembly Bill 341: Revenue for Domestic Violence Programs

Assembly Bill 341 would explicitly permit, but not require, counties to use a portion of the marriage license fees they collect for education, training, or services related to domestic violence. In addition, the bill would increase, from \$50 to \$75, the domestic abuse assessment paid by individuals convicted of domestic abuse offenses.

On August 12, 2003, the Assembly Committee on Children and Families recommended passage of AB 341 by a vote of 7 to 0.

#### **CURRENT LAW**

Marriage License Fee. The current statutory fee for a marriage license is \$49.50. Of this amount, \$25.00 is forwarded to the State Treasury and deposited to the general fund. The remaining \$24.50 is retained by the county that issues the marriage license, of which \$20.00 must be used for family court counseling services. Because the county clerk also receives a \$0.50 standard notary fee, the minimum fee an applicant pays for a marriage license in Wisconsin is \$50.00. In addition, counties may increase the statutory fee by any amount and retain the additional revenue generated from that increase. In 2003, marriage license fees (including the standard notary fee) varied from the minimum amount of \$50.00 in 24 counties to \$95.00 in Waukesha County.

Domestic Abuse Assessment. If a court imposes a sentence on an adult or places an adult on probation for violating certain crimes against life and bodily security, crimes against property, bail jumping, or crimes against public peace, order, and other interests, regardless of whether any fine is imposed, the court must also impose a domestic abuse assessment for each offense (unless the court determines that the assessment would have a negative impact on the offender's family). For these

convictions, the domestic abuse assessment applies only to those cases in which the defendant's conduct was directed against a spouse or former spouse, against an adult with whom the defendant resides or formerly resided, or against an adult with whom the defendant has created a child. The court must also impose the assessment if the court convicts a person of knowingly violating a temporary domestic abuse restraining order or injunction.

Currently, the domestic abuse assessment is \$50 for each offense. Counties forward all revenue from the assessment to the state. This revenue is credited to a PR continuing appropriation in the Department of Health and Family Services (DHFS), which the Department distributes, in combination with other state and federal funds, as grants for services to victims of domestic violence. In 2002-03, DHFS received \$387,600 in program revenue from this source.

#### SUMMARY OF BILL

AB 341 would allow, but not require, counties to use any or all of the county share of the marriage license fee revenue to support education, training, or services related to domestic violence. The county share is equal to the difference between the license fee, the \$25.00 paid to the state and the \$20.00 to support family court counseling services. At a minimum, this amount would be \$4.50 per license.

AB 341 would also increase the domestic abuse assessment by \$25, from \$50 to \$75. This increase would apply for any sentence imposed by a court on or after the bill's effective date, regardless of when the offense was committed.

#### FISCAL EFFECT

Based on the program revenue DHFS received from the domestic abuse assessment in 2002-03 (\$387,600), a 50% increase in the domestic abuse assessment is estimated to increase annual revenues to support domestic abuse grants by approximately \$193,800. Depending on the bill's effective date, some of these additional revenue may be received in 2003-04. The provision that would explicitly authorize counties to use a portion of the marriage fee license revenue they retain on domestic abuse services would have no effect on county or state revenue or costs.

RE: Support for Assembly Bill 341

Assembly Bill 341 is scheduled for review by the Committee on Joint Finance on Monday, November 10, 2003. On behalf of the Wisconsin Coalition Against Domestic Violence (WCADV), a non-partisan, statewide membership program representing domestic violence programs and victims and their children, I urge you to support the language offered in this bill.

Currently, 58 non-profit agencies and 11 tribes receive funding from the Department of Health and Family Services (DHFS) to provide services to victims of domestic abuse and their children at over 100 program sites in Wisconsin. Domestic abuse services are offered in all 72 counties. In the past five years, domestic abuse programs have experienced a more than 30% increase in requests for services. Yet, there have been no significant increases in state funding to domestic abuse programs since 1997. Instead in 2003, for the first time, the state cut funding to domestic abuse programs by three percent in response to a larger state budget crisis.

Wisconsin domestic abuse programs provide direct services to well over 30,000 women, children and men each year, a number that has been steadily increasing. And while public and governmental support for services to families experiencing domestic violence has steadily increased, the current funding climate puts these critical services at high risk for reduction or elimination altogether. If the state decrease of 3% was the only funding cut that domestic abuse programs were facing, such a reduction could be absorbed by many programs. However, local domestic abuse programs are now facing funding cuts from many of their long-time funding sources despite the dramatic increases in the numbers of persons needing services. At this time, we are anticipating that local domestic violence programs will experience an overall loss of between 20-30% of their funding within the next year. Reductions in federal funding sources (Victim of Crime Act, Violence Against Women Act, Family Violence Prevention and Services Act, and Housing and Urban Development); as well as the 3% state reduction; the loss of \$750,000 in federal funds to the Refugee Family Strengthening Projects; and cuts from County/City government, United Way and dramatic decreases in charitable giving contribute to this funding crisis. The grid below illustrates the reductions that local domestic violence programs are experiencing. While the grid indicates the losses are "anticipated", WCADV is now being flooded with calls from local programs as they receive word of vastly reduced funding

Assembly Bill 341 provides a practical solution, at least in part, to the funding crisis now facing local domestic abuse providers. The bill does two things: 1) it increases the domestic abuse assessment paid by domestic batterers upon conviction and 2) it calls attention to the fact that units of local government can utilize a portion of the marriage license fees collected by counties to fund domestic abuse services. The increase in the domestic abuse assessment, the first ever in nearly 15 years, puts at least part of the responsibility for the need to fund domestic abuse services squarely where it belongs: on the shoulders of batterers. The proposed change to marriage license fees merely provides a suggestion that funds can be used for domestic abuse services. This change does not increase marriage license fees nor does it mandate counties to use fees for the purpose of providing domestic abuse services. However, as many counties are now cutting funding to local domestic violence service providers, it will give those counties a place to look for potential replacement funding.

<sup>&</sup>lt;sup>1</sup> Figure is based on cummulative 2002 budgets of domestic abuse programs in Wisconsin. The 2003 total may be more or less than this figure, therefore this amount should be considered an estimate.

<sup>&</sup>lt;sup>2</sup> Please note: these calculations are based on approximations. Except where specifically noted, it is impossible to know exact amounts of reductions for several of these funds. Funds are not divided equitably among all states, however for purposes of approximate calculations each known reduction was divided equally among the 50 states. Wisconsin will lose \$623,000 VOCA Victim Assistance funds in 2003 allocations. Approximately 50% of Victim Assistance grants are awarded to domestic abuse programs equaling approximately \$311,500. FVPSA has been reduced by \$500,000 in FY 2004 divided by 50 states equals \$10,000. HUD is reduced by \$250 million for FY 2003. This number, divided by 50 states equals \$500,000. VAWA programs have been reduced by \$4.1 million, divided by 50 states equals \$82,000. Figures are for Federal FYs 2003 and 2004. Future reductions beyond this point are not yet known.

<sup>&</sup>lt;sup>4</sup> These losses are expressed as a range because at this time, it is difficult to estimate the long-term effects of the recession on charitable giving both to foundations that support local domestic abuse services and direct contributions to programs. Many programs have already been informed by local United Way agencies that they will suffer reductions ranging from 10-50%. Additionally, any reductions in Shared Revenues will be passed on to local domestic abuse programs by County and City funders. Some programs lost local funding in 2001-02 after the proposed cuts to the Shared Revenues program by Governor McCallum. Those programs that suffered reductions did not have funding reinstated despite the continuation of the Shared Revenues program.

Those hurt most by lack of services are that need domestic abuse services. Sadly, the choice by many local funders to dramatically reduce, or eliminate domestic abuse funding altogether, will not ultimately yeld a virge These communities will likely see increases in requests for law enforcement assistance, increased health care costs and emergency room visits, employers will suffer lost productivity, and children from violent homes will be less likely to be successful in school. The societal cost of domestic violence is great. The presence of services to assist families in transitioning to services ultimately save more dollars than those services cost.

WCADV hopes that the funding reductions do not lead to the elimination of domestic violence services in any Wisconsin communities. However, we do know that services will be changed by being so greatly reduced. AB 341 will provide an opportunity to replace some of those funding losses. Victims of domestic violence and their children count of services being there in their communities. WCADV is hopeful that you will look favorably upon AB 341 so that those families experiencing abuse receive the support they so critically need.

AB 341 authorizes counties to use the marriage license fee for purposes related to domestic violence and increasing the assessment imposed on persons convicted of domestic abuse offenses.

This bill does NOT require counties to use the \$4.50 of the \$24.50 obtained for domestic abuse education, etc purposes. It simply clarifies that that \$ can be used for these purposes.

The only thing that this bill changes from current law is that 1) it clarifies that \$ can be used for dom violence (which isn't really a change) and 2) raises domestic abuse assessment from \$50-\$75 for each offense.

Dear Senators;

Assembly Bill 341 has been scheduled for action on today's Senate floor calendar. This bill is a critical piece of legislation for local domestic violence programs. It is supported by the WI Coalition Against Domestic Violence, the Governor's Council on Domestic Abuse, and local domestic abuse programs throughout WI.

During the past two years, local domestic abuse programs have lost unprecedented levels of funding. Federal sources have been cut (VOCA, VAWA, and FVPSA), Wisconsin reduced funding for domestic abuse programs by 3%, local funders (counties and cities) have passed on cuts in shared revenues to domestic abuse programs, and charitable giving is at an all time low causing many foundations, such as the United Way, to reduce funding levels for local programs.

This bill can help stabilize funding for domestic abuse programs in two ways:

1-It increases the domestic abuse penalty assessment, an assessment paid by CONVICTED domestic abuse offenders, by \$25. The domestic abuse penalty assessment has existed since 1989 and has never been raised in 15 years. The assessment collections are treated as program revenue by the state and are funneled directly back to local domestic abuse programs as a portion of the state's Domestic Abuse grant program administered by DHFS. It is anticipated that raising the assessment could generate an additional \$200,000 in revenues for domestic abuse services. Although this amount is not even equal to the 3% state funding cut experienced last budget, much less the rest of the funding losses, it will certainly be helpful in offsetting some of the losses suffered by these critical programs.

2-It opens the possibility for counties to utilize some of the funds they retain from marriage license fees to fund local domestic abuse services. It

does not raise marriage license fees nor does it require counties to use the funds for domestic abuse services. It merely creates the possibility. Local government will still decide how best to spend those dollars and if they believe funding domestic abuse services is a priority, they can use marriage license revenues to do so.

I have attached a memo that I prepared for Joint Finance on this issue. I hope it will provide any additional information that you find necessary in evaluating your decision to hopefully support this bill. This bill has passed the Assembly Committee on Children and Families unanimously, passed Joint Finance unanimously, passed the Assembly unanimously, and passed the Senate Committee on Health, Children, Families, Aging and Longterm Care unanimously. It is unopposed by any organization (please note: the Ethics Board website does note that Dean Medical and St. Mary's Hospital oppose this bill...we have been informed that was an erroneous entry by those organizations who believed they were registering against AB 314. Thus far the Ethics Board has not removed this error from the website however, Michael Heifetz, lobbyist for both organizations, assures us that Dean and St. Mary's have no opposition to AB 341).
