On behalf of the nearly 20,000 sporting men and women across Wisconsin who have been active in our organization's efforts, thank you for your continued support of the Sporting Heritage Amendment. You were with us at the start of our efforts to build grassroots support to permanently protect our Right to Hunt, Fish and Trap in the Wisconsin Constitution.

Your efforts have been an invaluable part of our efforts to introduce the Sporting Heritage Amendment to grassroots activists across Wisconsin. You stood with us at the very first announcement of this amendment in the summer of 2000. 

Good afternoon Senators. Thank you for the opportunity to testify on this important initiative. And thank you Senator Zien and Rep. Gunderson for bringing this legislation to a speedy hearing. I appreciate all the work you and other supporters and sponsors of the right to hunt and fish have done protect the rights of current and future generations of Wisconsin sportsmen and women.

My name is Bill Skewes and I am here today as a private citizen and a co-founder of Sporting Heritage, a non-profit organization dedicated to preserving the rights of Wisconsin sportsmen and gun owners. You may recall that we were formed for the purpose of passing the Right to Keep and Bear Arms amendment in the fall of 1998. And we helped organize the support for passage of the Right to Hunt and Fish (first consideration). We are here again today to urge you pass this important legislation as soon as possible.

Sporting Heritage believes that enshrining the right to hunt fish and trap in the state constitution will protect this cherished tradition for future generations. As our society becomes more urbanized, fewer and fewer of our citizens have any connection to the land or an understanding of the role that hunters and anglers play in conservation. Some have even argued that this legislation is not needed because there is no threat to hunting and fishing.

Yet, the animal rights movement, though marginalized, continues to gain steam and the number of organizations dedicated to banning hunting and fishing grows. By contrast, the number of hunters and anglers, as measured by license sales nationally, is on the decline. Even in Wisconsin, where we pride ourselves on our hunting and fishing traditions, the number of licenses sold over the past decade has remained static and is even projected to decrease. Therefore, the time to act is now. Not when our numbers are diminished but when we are strong. Again, thank you for moving this legislation forward and for your outstanding record of support of Wisconsin's hunters, anglers and trappers.
