




Gentlemen,

At our meeting, we discussed the issue of driver license seizures, and created s. 6.79 (7) in the bill was drafted to address this issue (p. 11, lines 20-25 of AB-63). Based upon additional information, I now believe the provision we created may be technically incomplete. I believe that, after the word "citation" on p. 11, line 20, the phrase "or notice of intent to revoke or suspend an operator's license" should be added, and on lines 23 and 24, the word "citation" should be changed to "citation or notice" to be technically accurate. The same change would have to be made in a couple of other places. Do you want me to prepare an amendment to make this change?
