3) Please draft a new amendment that removes the bill's language exempting employees who refuse on grounds of belief from disciplinary action or legal liability as a result of their actions.

4) Please draft a new amendment that changes the definition of "participate in" to include: "except in the case that refusing to participate in....violates any professional code ethics"

5) Please redraft LRB 3054/4 as a substitute amendment to AB 207.

- 4. Page 13, line 16: delete ", as defined in s. 450.155 (1) (a)" and substitute "that have been approved by the federal food and drug administration".
- 5. Page 15, line 21: delete ", as defined in s. 450.155 (1) (a)" and substitute "that have been approved by the federal food and drug administration".
