Hi Marc,

Rep. Musser has asked me to submit a drafting request for a bill to amend s. 71.05 (6)(b) 34. (which was created in 2003 Act 183) to do the following:

1. Delete the "(a)" in the current citation to 10 USC 12302. According to Col. Terry McArdle at the Dept. of Military Affairs, the orders into active service under this provision are not citing the "(a)" and that is causing some confusion.
2. Insert a reference to 10 USC 12301 before USC 12302. Col. McArdle says that this will cover persons called up for such service as the U.S.-based Noble Eagle missions.

**Analysis by the Legislative Reference Bureau**
