1 AN ACT *to create* 165.10 of the statutes; **relating to:** the authority of the
2 Department of Justice.

Analysis by the Legislative Reference Bureau

This bill gives the Department of Justice the authority to bring an action for injunctive or other equitable relief against a person who interferes with the exercise or enjoyment by an individual of a right secured by the constitution or laws of this state or of the United States.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 165.10 of the statutes is created to read:

4 **165.10 Civil rights enforcement.** If any person, whether or not acting under
5 color of law, interferes with the exercise or enjoyment by any individual of a right
6 secured by the constitution or laws of the United States, or of a right secured by the
7 constitution or laws of this state, the attorney general may bring an action for

2 enjoyment of the right secured.
