1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 5: after that line insert:

3 "(ag) "County of residence" means the county in which ^{ea}the sex offender resided
4 when he or she committed the offense that resulted in his or her being subject to s.
5 301.45 (1g). ^{ea}

6 (ar) "City, town, or village of residence" means the city, town, or village in which
7 ^{ea}the sex offender resided when he or she committed the offense that resulted in his
8 or her being subject to s. 301.45 (1g)."

9 2. Page 3, line 7: after that line insert:

10 "(2m) (a) A sex offender must live in his or her county of residence.

11 (b) If the county of residence in par. (a) contains a city of the first class, the sex
12 offender must live in his or her city, town, or village of residence.

1 (c) This subsection does not apply to a sex offender while he or she is confined
2 in an adult or juvenile correctional facility, a jail, or a house of corrections." ✓

3 3. Page 3, line 8: after "sub. (2)" insert "or (2m)".

4 4. Page 4, line 3: after that line insert:

5 "SECTION 3m. **Nonstatutory provisions.**

6 (1m) The treatment of section 301.48 (2m) first applies to a sex offender who
7 is released from an adult or juvenile correctional facility, a jail, or a house of
8 corrections on the effective date of this subsection or to a person who is required to
9 register as a sex offender beginning on the effective date of this subsection. In this
10 subsection, "sex offender" has the meaning given in section 301.48 (1) (d) of the
11 statutes, as created by this act."
