The Assembly Natural Resources committee held its hearing on AB 586, the hunting mentor bill. Rep. Hebl would like an amendment, to add a requirement for the mentor under s. 29.592 that the mentor must have the certificate of accomplishment showing completion of the hunter's education course, or a similar certificate from another state, province or county. The requirement would apply to all mentors, even those born before January 1, 1973.

The committee hasn't scheduled an exec yet.
