AN ACT ...; relating to: the barbering and cosmetology board.

examining

*Analysis by the Legislative Reference Bureau*

Under current law, the barbering and cosmetology examining board consists of 9 members appointed for 4-year terms. The board consists of four members who are licensed barbers or cosmetologists, 2 public members, one member who is a representative of a private school of barbering or cosmetology, one member who is a representative of a public school of barbering or cosmetology, and one member who is a licensed electrologist.

Under this bill, an aesthetician may serve on the board, but the bill does not change the number of members on the board.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 15.405 (17) of the statutes is amended to read:

15.405 (17) BARBERING AND COSMETOLOGY EXAMINING BOARD. There is created a barbering and cosmetology examining board in the department of regulation and licensing. The barbering and cosmetology examining board shall consist of 9 members appointed for 4-year terms. Four members shall be licensed barbers,

**SECTION 1**

1 aestheticians, or cosmetologists, 2 members shall be public members, one member  
2 shall be a representative of a private school of barbering or cosmetology, one member  
3 shall be a representative of a public school of barbering or cosmetology and one  
4 member shall be a licensed electrologist. Except for the 2 members representing  
5 schools, no member may be connected with or have any financial interest in a  
6 barbering or cosmetology school.
