1 **AN ACT** *to create* 13.025 and 13.45 (8) of the statutes; **relating to:** prohibited
 2 meeting times of the assembly, senate, and legislative members of committees
 3 and other bodies.

Analysis by the Legislative Reference Bureau

This bill provides that the daily sessions of the assembly and senate and the meetings of its committees end no later than midnight and prohibits the houses and committees from meeting or conducting business between midnight and 8 a.m. The bill also prohibits legislative members of committees and other bodies from meeting or conducting business on such a committee or other body during that period.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 13.025 of the statutes is created to read:
 5 **13.025 Prohibited meeting times of the assembly and senate.**
 6 Notwithstanding any rule of either house, the daily session of each house ends at
 7 midnight, unless adjourned earlier, and neither house may meet or conduct business
 8 during the hours between midnight and 8 a.m.
