

Whereas, Sergeant Van Zoest received numerous commendations for his exemplary service to his country including, the Bronze Star Medal, the Purple Heart, the Good Conduct Medal, the Reserve Components Achievement Medal, the National Defense Service Medal, the Afghanistan Campaign Medal, the Global War on Terrorism Service Medal, the Armed Forces Reserve Medal, the North Dakota Legion of Merit, the Army Combat Action Badge, and the Expert Marksman Badge; and
