1. Page 1, line 2: ~~after~~ ^{delete County} "Calumet" ^{insert} "and St Croix".

2. Page 1, line 5: after that line insert:

"SECTION 1m. 753.06 (10) (k) of the statutes is amended to read:

753.06 (10) (k) St. Croix County. The circuit has 3 branches. Commencing August 1, 2007, the circuit has 4 branches."

3. Page 2, line 3: after that line insert:

"(1g) The initial election for circuit judge for branch 4 of the circuit court for St. Croix County shall be at the spring election of 2007 for terms commencing August 1, 2007, and ending July 31, 2013."

4. Page 2, line 4: delete lines 4 to 7 and substitute:
