4 Wisconsin and died on June 13, 2005, as a result of injuries suffered when a roadside  
5 bomb exploded outside of his Humvee as part of combat operations in Al Anbar  
6 Province, Iraq; and

7 Whereas, LCpl Mattek was a member of the United States Marine Corps, 2nd  
8 Light Armored Reconnaissance Battalion, Regimental Combat Team-2, 2nd Marine  
9 Division, II Marine Expeditionary Force, out of Camp Lejeune, North Carolina; and

10 Whereas, LCpl Mattek was a 1999 graduate of Antigo High School, where he  
11 served as class president his freshman, sophomore, and senior years, was the  
12 student council president, and participated in football, wrestling, and track; and

13 Whereas, LCpl Mattek attended the University of Wisconsin-Steven Point,  
14 where he played football and rugby; and
