

University of Wisconsin System - Reimbursement of the Special Counsel Appropriation, s. 20.455 (1) (b) by appropriations s. 20.285 (1) (a), 20.285 (1) (h) and 20.285 (1) (j)

The UW System currently makes use of the Special Counsel appropriation, s. 20.455 (1) (b) for legal services of the UW- Extension's Public Broadcasting operation. They get this special counsel to assist them with Federal Communications Commission legal requirements. The draft would say that do the extent that s.20.455 (1) (b) is used for Public Broadcasting activity, that the three appropriations supporting the UW Systems public broadcasting operations, s.20.285 (1) (a), (h) and (j) should reimburse the special counsel appropriation for those services.
