

The bill requires the director of the Office of State Employment Relations to conduct a study of compensation paid to administrators in state agencies in the executive branch of state government, including specifically compensation that is paid to administrative executives and officers employed by the Board of Regents of the UW System, and to submit a report of the results of the study to the secretary of administration. The report must include recommendations for addressing any disparities in administrator compensation.
