Pam,
I have the following drafting requests, based on the JFC actions on Monday 6/6/05:

- AB 100 section 9255 under 20.145 (1)(g), please reduce the 2006-07 lapse from \$7,741,300 to \$3,038,300. The Committee chose alternatives 1 and 3 in paper 452. Alternative 1 clarifies that, of the \$7,741,300 listed in AB 100 § 9255 as lapse from 20.145(1)(g) in 2006-07, only \$3,038,300 is lapse -- the remaining \$4,703,000 is tax revenue to the general fund.
- Motion #775 re: HIRSP privatization passed. Other than eliminating the word "terminating" from line 12 on page 17 of LRB0243/P5, I know of no other changes ... at least none based on the Committee's action.
