


1 At the locations indicated, amend the substitute amendment as follows:

2 #1. Page 182, line 5: increase the dollar amount for fiscal year 2005-06 by  
3 \$944,500 and increase the dollar amount for fiscal year 2006-07 by \$944,500 to  
4 increase funding for the purposes of maintaining the regional office in Milwaukee  
5 and of increasing the authorized FTE positions for the department by 9.0 GPR  
6 positions for the regional office in Milwaukee.

7 #2. Page 488, line 15: delete "\$16,060,000" and substitute "\$17,004,500".
