Jeff and Loni,

We'd like to get two simple amendments drafted to AB 211.

#1: In Section 10, on page 6, lines 10-12, delete the amendment language and instead insert the following: Names, addresses, license numbers, and social security numbers obtained by the department under this subsection shall be provided to the department of revenue for the purpose of administering setoffs under ss. 71.93 and 71.935 and state taxes. [this language was provided by the department and is identical to that drafted in section 6 of AB 68]

#2: Create a new section to modify 71.93(5), using language similar to that in Section 5 on page 4, lines 24-25 and page 5 lines 1-6. The purpose of this amendment is to give DOR the ability to have a single method of administering this program, providing consistency in the method of charging other state agencies along with counties and municipalities.

The Assembly committee is hearing the bill on April 20th. Please call me if you have questions. Thanks.

1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 4, line 13: after that line insert:

3 "SECTION 3m. 71.93 (5) of the statutes is amended to read:

4 71.93 (5) ~~STATE AGENCY DEBTOR~~ CHARGED FOR COSTS. At the time of each

5 settlement, each ~~state agency debtor~~ shall be charged for administration expenses,

6 and the amounts charged shall be credited to the department's appropriation under

7 s. 20.566 (1) (h). The department may set off amounts charged to the debtor under

8 this subsection against any refund owed to the debtor, in the manner provided in sub.

9 (3). Annually on or before November 1, the department shall review its costs

10 incurred during the previous fiscal year in administering state agency setoffs and

11 shall adjust its subsequent charges to each ~~state agency debtor~~ to reflect that

12 experience."
